# Opening

## **Confirmation of the Minutes of the previous Annual General Meeting**

## **President's Report**

Owing to the technological issues that delayed the start of the AGM, the president made a brief summary of his report. Refer to the attached copy of the report for details. In summary:

#### <u>General</u>

The President highlighted the contrast between the 2018-19 year and the 2019-20 year. In particular, he mentioned the fires in Namadgi National Park which are still preventing COG members from birding in some favourite places and the restrictions caused by the COVID-19 pandemic. The Northern Shoveler, observed at Kelly's Swamp in September 2019 and again in July 2020, was a notable rarity for the year. Neil also noted that the Rarities Panel has recently updated the list of birds that are considered to be rare in the ACT.

#### Committee

The committee met eleven times during the reporting year and continued to act on behalf of COG members. The meetings from March to June, inclusive, were held remotely.

The committee was greatly assisted by other members whose support was even more important this year than in other years.

### Databases and data management

Neil noted that work to replace COG's databases is under way.

## **Monthly Meetings**

Jack Holland continued to provide interesting speakers for the COG monthly meetings which occurred until March. After a few months of silence, monthly meetings recommenced virtually in July. Neil noted the difficulties of having on-line meetings.

#### CanberraBirds email announcement and discussion list

The list continued to be managed by David McDonald. Neil announced that the recent issues would soon be resolved as the discussion list was being moved to a new provider.

All the COG members who had contributed over the year to COG in many ways were thanked for their efforts in this unusual and difficult year.
